


2022 Google earth. Location of the site.




2022 Google earth. Detail of the site.

#### Location

1-5 Central Avenue, Sittingbourne, Kent, ME10 4BX. The N-S building is situated on the corner of Central Avenue with its main façade to the west facing Central Avenue and the north façade onto the High Street where it is numbered No87. Centred on TQ 90655 63637.

## Listing

## **Scope of this Report**

This report records examines the historic records, features and mapping associated with the building to inform the addition of an extra storey and the conversion of the upper floors to dwellings. It acts as a Heritage Impact Assessment Statement dealing in particular with the affect on the Conservation Area and the nearby Listed buildings. For planning records the site is called 5 Central Avenue and 87 High Street.










2023. First floor plan. Ken Judge Associates.

## **Setting and Description**

The former Town Hall during its demolition in the mid 1960's. Central Avenue is in place.

The building is set on the corner of Central Avenue and is canted on the NW corner. The main retail area is taken by NatWest Bank, 87 High Street, Sittingbourne, Kent. ME10 4 AU. On the west elevation there are two retail outlets offering coach holidays and whole foods. The upper floors are advertised as office space.

The three storey building is a typical concrete and steel building in the Modernist or even Brutalist style that swept Britain in the 1960's and was extensively used for public buildings including shops and schools. A good local example would be the Sittingbourne East Secondary School.


The building was erected on the site of the Town Hall which was originally the Corn Exchange put up in 1850 and demolished in the mid 1960's. The historic photograph shows the Barclays Bank next door and the adjacent buildings have little changed in exterior appearance. The clock tower was considerably higher than the other buildings.

1840 Tithe Map for Sittingbourne superimposed over the 2023 Ordnance Survey.




1840 Tithe Map for Sittingbourne IR29/17/331.

Plots 105 High Street House & Garden occupied by Henry Back, 106 High Street Cottage & Garden occupied by Rachel Reeve were both owned by James Barnard. Plot 107 Not recorded, 110 Yard and Stables owned by William Mackay and occupied by Paul William Gordelier, all lie within the footprint of the modern building. The adjacent Plot 104 High Street House & Garden was owned and occupied by John Amdell Barnard.



1866 Ordnance Survey.


The Corn Exchange was built in c.1850 on the site of the present building.



1896 Ordnance Survey.


By 1896 the building is identified as the Town Hall and has an extension to the west.


1906 Ordnance Survey.




## **Heritage Impact Analysis of the Proposed Scheme**

### It is proposed to convert the offices into accommodation.

Reference: 23/502228/PAMEET

Proposal: Proposed change of use of the existing second floor from Office Use (Class E) to residential use (Class C3) including the construction of an additional third floor to create self-contained residential flat units. Proposed three storey rear extension to create self-contained residential units to the first and second floors with separate Ground Floor entrance. Location: 1-5 Central Avenue, Sittingbourne, Kent, ME10 4BX.

## 1. Proposed three storey rear extension.

The extension is not to the rear (east elevation) of the building but to its south elevation and increases the length of the building by approximately one quarter. This increases the roadside presence onto Central Avenue and therefore has no impact on the heritage assets in the High Street. Central Avenue was created in the early 1960's before the Town Hall was demolished to make way for No87 High Street and 1-5 Central Avenue.

## 2. Proposed third floor.

- 2.1. The proposed third floor is to the same height as the current plant room but is most of the length of the building. It has been recessed from the High Street such that it is difficult to see it other than from a great distance and therefore would have negligible effect on the setting of the Listed buildings.
- 2.2. It may be possible to see the back (south elevation) of 78-81 High Street (Barclays Bank). However, this will be no more intrusive that the current fenestration on the eastern elevation.

## **Significance**

No87 High Street and No1-5 Central Avenue were built in the mid 1960's on the site of the 1850 Corn Exchange, later the Town Hall. Prior to the demolition of those buildings a row of other historic buildings, shown on the 1868 Tithe Map were demolished and Central Avenue was formed.

The building design has its roots in the International Moderne style first championed in Silver End, Essex by Crittalls in the 1920's and then expressed as Brutalism. Brutalist architecture is a style of building design developed in the 1950s in the United Kingdom following World War II. With an emphasis on construction and raw materials, the aesthetic evolved as reconstruction efforts were underway in the post-war era. It was most famously expressed in 1963 with the building of the Economist Building in London. The buildings rely on steel or reinforced concrete frames, blockwork partitions, concrete panels and large glass panes.

Because the relatively lightweight structures could be quickly fabricated off-site they were favoured by government architects for public building like schools, of which hundreds were built in the 1950's and early 1960's. The style was particularly used for schools, fire stations, airport buildings, multi-storey car parks and shopping complexes.

The style dated very quickly as the buildings are often bland, featureless and dour, reflecting Communist ideals that were not popular in the UK. The building is not inspiring and the concrete is dirty giving the building an uncared for appearance.
